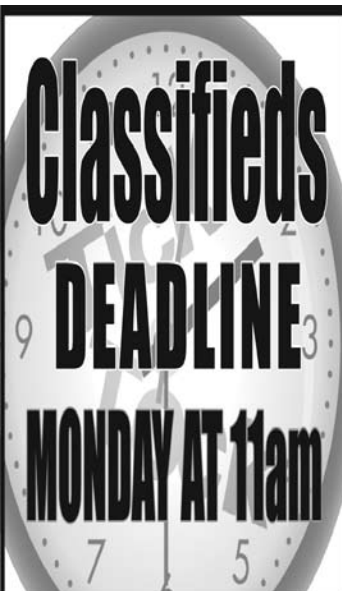

The Hays Lodgepole School District is accepting proposals for renovations at Lodgepole Elementary School, the elementary gym, and four teacher housing units.
